THE DECREE OF THE RECTOR OF UNIVERSITAS NEGERI SURABAYA NUMBER 736/HK/KM/2023

CONCERNING THE CONVERSION OF NATIONAL CREDIT SYSTEM TO EUROPEAN CREDIT TRANSFER SYSTEM

RECTOR OF UNIVERSITAS NEGERI SURABAYA,

Considering

- : a. that International Accreditation is an acknowledgment of the quality of an educational institution by an authorized agency/organization according to the evaluation criteria of an accreditation institution;
 - b. that recognition of quality from external parties including input, process, output, outcomes, and quality assurance system in higher education;
 - c. that the government realizes the importance of higher education quality and there is a need to develop a holistic quality assurance system to improve academic quality in enhancing the quality standards of education, research, and services in Indonesia to meet the international standards continuously;
 - d. that it requires a credit equivalent (Credit Unit) applied by Universitas Negeri Surabaya toward the European credit transfer system to be counted when used to apply advance study in Europe;

DECREE OF THE RECTOR OF THE STATE UNIVERSITY OF SURABAYA CONCERNING DETERMINATION OF THE EQUALITY OF THE UNESA SEMESTER CREDIT SYSTEM (SKS) AND THE EUROPEAN CREDIT TRANSFER SYSTEM (ECTS).

FIRST

For the Undergraduate Program (minimum 144 CU/229 ECTS), Based on the regulation of the minister of education and culture of Indonesia number 3 of 2020 concerning National Higher Education Standards, it is stated 1 CU equals to 170 minutes per week. Therefore, in one semester (16 weeks, including midterm and final exam) 1 CU = 170 minutes x 16 = 2.720 minutes or 45.3 hours. Therefore, workhours in 144 CU x 45.3 hours= 6.523.2 hours. UNESA decided that 1 ECTS with 144 CU, 6.523.2/229 ECTS = 28.48 hours, so that 1 CU = 1.59 ECTS (45.3 hours/28.48 hours).

SECOND

For Master Program (minimum 36 CU/81 ECTS), 1 CU equals 240 minutes (50 minutes face to face and 90 minutes assignment, 100 minutes independently so 1 CU = 2.24 ECTS (64 hours/28.52 hours).

THIRD

: For Doctoral Program (minimum 42 CU/106 ECTS), 1 CU equals 270 minutes (50 minutes face-to-face and 100 minutes assignment, 120 minutes independently so 1 CU = 2.52 ECTS (72 hours/28.52 hours).

FOURTH

: The calculation of the determination of the credit score equation can be used for students who will transfer to UNESA or UNESA students who will go to education areas in Europe with the terms and conditions apply.

FIFTH

: This Rector's Decree comes into effect on March 02, 2023.
